It includes approximately 2,000 of the smallest securities based on a combination of their market cap and current index membership. *The Barclays Capital US Aggregate Bond Index* is an unmanaged index generally representative of intermediate-term government bonds, investment grade corporate debt securities and mortgage-backed securities.
